KNOW ALL MEN BY THESE PRESENTS, That Rosa H. Marchbanks, of
the County of Greenville,

in the State aforesaid,
in consideration of the sum of
Two Thousand Dollars and other Valuable ^{Consideration} DOLLARS,
to me in hand paid
at and before the sealing of these presents by H. P. McGee

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release
unto the said H. P. McGee the following described real

estate, to wit: "All that certain piece, parcel
or lot of land situate, lying and being in the
County and State aforesaid, in the City of
Greenville, on the west side of Wilton Street,
beginning at a stake on the west side of
Wilton Street at a point two hundred (200)
feet South of the South west corner of Wilton
and Randall Street and running thence N. 1-41
E. One hundred thirty-three + 1/2 (133 1/2) feet to a
stake on Wilton Street, thence N. 83-13 W. two
hundred (200) feet to a stake thence in a line
parallel with said Wilton Street S. 1-41 W. one
hundred thirty-three + 1/2 (133 1/2) feet to a stake;
thence S. 83-13 E. two hundred (200) feet to the
beginning this being parts of lots nos. 27 + 29
of Sect. "B" of a plat of Stone Land Company,
said plat recorded in C. M. C. Office in Plat
Book "A" pp. 337-345 - and being part of the
land deeded me by E. Jernan, Master, Jan. 15th,
