unto the said Myra L. Cox, her heirs and assigns forever.

All that piece, parcel or lot of land situate on the south
side of West Washington Street, in the City of Greenville, County of
Greenville, and State of South Carolina, and having the following
metes and bounds to wit: Beginning at an iron pin on the
south side of said West Washington Street seven hundred
twenty six and one-half (726 1/2) feet west of Westfield Street,
being the corner of the lot formerly owned by Mrs. L. L. Murre-
lith, and running thence with the line of said lot S. 28-15
W. two hundred and twenty-one and one-half (221 1/2) feet
to an iron pin on Morgan's line; thence with said
Morgan's line N. 65-45 E. fifty (50) feet to an iron pin
at the corner; thence with the line of Dean and Noble
N. 28-15 E. two hundred and twenty six (226) feet to an
iron pin on the south side of said Washington Street;
