Milford All of my right title & interest, which is one half in those two certain lots or parcels of land situated in Greenville County State of So. Ca. in the Sixth Ward of the City of Greenville and known as lots number fifteen (15) and fifteen (15) one plat of the estate of Mrs. S. E. Crenshaw made by H. D. Neves on Oct. 22nd 1913 & recorded in office R. D. C. in plat Book C at page 261 Lot 220 15 fronting on both Edwards and Thruston Sts. Sixty feet width w/ depth of 110 ft. Lot 220 5 fronts on Augusta Street (58 1/2) feet fifty-eight & five tenths ft. & on Edwards St (136) one hundred & thirty six feet. Being the lots conveyed to H. T. Henderson & J. G. Milford by Wm.
