DEED TO Charles F. Hard

KNOW ALL MEN BY THESE PRESENTS, That I, J.P. Ballenger, of the
County of Greenville,

In the State aforesaid,
in consideration of the sum of
One Dollar and other valuable considerations DOLLARS,
to me in hand paid
at and before the sealing of these presents by Charles F. Hard

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Chas. F. Hard, his heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being in the Fairsth Ward of the City of Greenville, State and County aforesaid, and being known as Lot 7 No. 30 of Oakland Heights, as shown by plat of said property recorded in the R. M. C. Office for Greenville County, in Plat Book Court page 144, and having the following metes and bounds, to wit: Beginning at and iron pin corner of lot No. 29 and 30, and running thence along line of lot No. 27 to 34-50 due hundred fifty (150) feet to an iron pin corner of lots 23, 24 and 29, thence S. 62-19 E. Sixty (60) feet to an iron pin, thence S. 34-50 W. one hundred fifty (150) feet to an iron pin on Choice Street, thence along said Choice Street N. 62-17 W. eighty (60) feet to the beginning corner, and being the same lot conveyed to me by S. P. Stover by his deed dated 19th day of February, 1917, and recorded in the R. M. C. office for Greenville County in Vol. 46 at page 134. See also Vol. 41 at pages 50, and Vol. 41 at page 84.

As a part of the consideration of this deed of conveyance, it is hereby understood and agreed that the said Chas. F. Hard, is to assume and pay a mortgage of Fifteen Hundred (\$1500.00) Dollars, given by J.P. Ballenger to Kindness Bill Hamilton, as Guardian and Mrs. Goldsmith, as General agent, said mortgage dated March 9th, 1917, and recorded in the R. M. C. office for Greenville County in Vol. 46 at page 136.
