to *W. H. Green*, paid by *W. H. Green*

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *W. H. Green*,

all that piece, parcel or lot of land in *Greenville*, Township, Greenville County, State of South Carolina,

In the City of Greenville, on the west side of Rutherford Street, beginning at a point on Rutherford Street, corner of an alley, and running thence with Rutherford Street S. 0° 50' W. 50 feet to stake corner of lot owned by J. W. Batoni; thence with Batoni's line S. 76° 15' W. 131 feet more or less, to fence post; thence with fence N. 17° W. 51.2 feet, more or less, to fence post in line of property of Mary Ella Walker, et al; thence with said Walker line N. 69° 05' E. 23.8 feet, more or less, to stake at corner of alley; thence with alley N. 0° 40' E. 123 feet, more or less, to point on Rutherford Street, the beginning corner.

The grantee herein assumes and agrees to pay the paving assessment against the above described lot due in September 1919.

Taxes for the year 1919 are to be prorated.

The grantee assumes and agrees to pay a note of the grantor to M. C. Eisemann, for \$1,500, secured by a mortgage of the above described premises recorded in Book 70, page 132.

The above described land is a portion of the same conveyed to me by *J. A. Wallace* on the 29th day of October 1918, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book 29, Page 169.

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *J. A. Floyd*,

all that piece, parcel or lot of land in *Greenville*, Township, Greenville County, State of South Carolina.

In Ward Six of the City of Greenville, on the northeast corner of Houston Street and Lucille Avenue, and having the following lines and boundaries: Beginning at an iron pin on the corner of Houston Street and Lucille Avenue, and running thence with Lucille Avenue, N. 88° 16' 2.2 feet, to corner of lot 720.6 of Section H, as shown on plat recorded in Office of Register of Mesne Conveyance for Greenville County, in Plat Book 6, page 41; thence with lot 720.6 N. 2. W. 60 feet; thence in a line parallel with Lucille Avenue S. 88° W. 163.1 feet to a pin on Houston Street; thence with Houston Street S. 2. W. 60.1 feet to the beginning corner, being all of Lot 720.4 and half of lot 720.5, of Section H, on plat of Chapin Springs Land Company recorded in Plat Book 6, page 41.
