all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

Near the corporate limits of the City of Greenville, S.C.
and being a portion of the subdivision known as
Overbrook, beginning at a stake on Spartanburg
Road, joint corner of lots #35 and #36, and running
