in the State aforesaid, the receipt whereof is hereby acknowledged, have granted bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *Gen. W. Surrine*, all that piece, parcel or lot of land in *Greenville* Township, Greenville County, State of South Carolina.

On the East side of McD Avenue in City View, as shown on plat made by W. A. Adams, Surveyor, and having the following boundaries; Beginning at an iron pin 200 feet from the South side of Summit Street and running thence with line of lot of D. B.
