KNOW ALL MEN BY THESE PRESENTS, That J. J. Aiken

in the State aforesaid,
in consideration of the sum of
Two thousand one hundred (\$2,100.00) DOLLARS,
to me in hand paid
at and before the sealing of these presents by Mrs. Bessie Walker

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

Mrs. Bessie Walker, her heirs and assigns forever, the following described real estate to wit: All that certain piece, parcel and lot of land, situate lying and being in the County and State aforesaid, being a portion of the lands of the Riverside Land Company known as "Riverside". Said lot being known and designated on a plat of said lands made by Carter & Pringle, Surveyors, (which plat is of record in my said office) as lot number 14 of Block "C" fronting fifty feet on Carolina Avenue, beginning at an iron pin on corner of Cedar Lane Road, thence running fifty feet N. with Carolina Avenue to an iron pin; thence straight across said Block one hundred sixteen feet to an iron pin adjoining the C. & G. Right of Way; thence running S one hundred twenty six and six tenths feet with said right of way to an iron pin on Cedar Lane Road; thence with said road one hundred twenty five and four tenths feet to the beginning corner, and being the same lot of land conveyed to me by the Riverside Land Company by deed bearing date Aug. 15, 1912, which deed is recorded in the R. M. C. Office for the County and State aforesaid in Vol 2 at page 100.

Also all that certain piece, parcel and lot of land situated, lying and being in the County & State aforesaid, being a part of the lands of the Riverside Land Company, known as "Riverside", said lot being known and designated on a plat of said lands made by Carter & Pringle, Surveyors, (which plat is of record in said office) as lot number 13 of Block "C" fronting fifty feet on Carolina Avenue, the said lot having the courses and distances and metes & bounds as will appear by referring to the above mentioned plat, reference to which is hereby made, and being the same lot conveyed to me by the Riverside Land Company by deed bearing date Feb. 18, 1917, and recorded in the R. M. C. Office for the County and State aforesaid in Vol. 2 at page 140.
