Rydell lot, and running thence with John Street S 49 30 E. 60 feet to an iron pin on John Street; thence N 47 30 E 181 feet; thence N 47 26 60 feet to an iron pin; thence S 41 45 E 183 feet and 9 inches to the beginning, being the same lot of land conveyed to us by John R. Raddale by deed dated the 2nd day of May, 1911, recorded in Vol. 11 page 468.
