KNOW ALL MEN BY THESE PRESENTS, That *W. L. Gassaway and M. D. Earle,*
of Greenville, County
in the State aforesaid,
in consideration of the sum of
Ten dollars, and other good and valuable consideration,
to *J. R. Hughey* ¹⁰⁰ ₁₀₀ ^{DOLLARS}
in hand paid
to and before the sealing of these presents by *J. R. Hughey*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said
J. R. Hughey, his heirs and assigns. All those two (2) cer-
tain pieces, parcel or tracts of land situate, lying
and being in the State of South Carolina, and County
of Greenville, in Grove Township, on the Pelzer Road, near
Piedmont, S. C. and having the following metes and bounds
according to a plat made by R. E. Dalton, Engineer,
dated April, 1919, to wit:
Beginning at a point on the C. & A. Railway, and run-
ning thence S. 40° 45' E. 1946.7 feet to a point on the P. & N.
Railway, thence along said Railway S. 5° 50' W. 2777 feet
to a stake on said Railway; thence leaving said
railway, and running S. 82° 45' W. 232 feet to a stake
on Pelzer Road; thence S. 1° 42' W. 300.2 feet to a pin in
said road; thence N. 4° 45' E. 256 feet to a pin in said
road; thence leaving said road and running N. 56°
50' W. 859 feet to a stake; thence N. 50° 48' W. 544.6 feet
to iron pin; thence N. 10° 40' E. 875 feet crossing Depot
Branch to the beginning corner, and containing as a
whole 25 $\frac{4}{5}$ acres, more or less, and being a portion
of the land conveyed to us by A. B. Pittman by deed
