DEED TO J. P. Batson

KNOW ALL MEN BY THESE PRESENTS, That

I, J. P. Burns, of the city and
County of Greenville,

in the State aforesaid,

in consideration of the sum of

Twenty Eight Hundred (\$2800.00)

DOLLARS,

to me

in hand paid

at and before the sealing of these presents by

J. P. Batson

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

J. P. Batson: - all that certain piece parcel or lot of land containing one-half acre, more or less, situate lying and being in Greenville Township, in the County and State aforesaid, North of the Finlay Bridge Road, 2½ miles west of Greenville Court House, and having the following metes and bounds, to wit: -

Beginning at a stake 3x0 East side of River Street, corner of lot no 3, Allerton lot and running thence with said lot S. 80 ¼ E. 210 feet to a stake 3x; thence N. 6 ½ E. 105 feet to a stake 3x; thence N. 80 ¼ W. 210 feet to a stake 3x on River Street; thence along East side of said Street S. 6 ½ W. 105 feet to the beginning corner.

Also all those two parcels of land each containing one-half of one acre, more or less, situate lying and being in Greenville Township, in the County and State aforesaid, being known in the late division of the Finlay lands as lots No. 7 and begin at a stake or stone 3x. on the main street or Finlay Bridge Road and running thence with said Road S. 80 ½ E. 105 feet to a stake 3x; thence N. 9 ¾ E. 210 feet to a stake 3x; thence N. 80 ¼ W. 105 feet to a stake 3x on line of lot no. 3, corner of lot No. 8; thence with lot no. 8 S. 9 ¾ W. 210 feet to beginning corner. Second: Lot lying North of and adjoining the first, and beginning at a stake 3x on River Street 210 feet from the main road and running thence S. 80 ¼ E. 210 feet to corner stake 3x of lot no 1; thence N. 9 ¾ E. 105 feet to a stake 3x, thence N. 80 ¼ W. 210 feet to a stake 3x on said River Street; thence along east side of said Street S. 9 ¾ W. 105 feet to the beginning corner.

Also all that piece parcel or lot of land containing one-half of one acre more or less lying and being in Greenville Township in the County aforesaid about two and one-half miles West of Greenville Court House on the north side of Cedar Lane Road and having the following metes and bounds, to wit:

Beginning at a stake 3x N. E. corner of said Cedar Lane Road and 40 foot Street and running thence along North side of said Road 105 feet to a stake 3x thence N. 9 ½ E. 210 feet to a stake 3x, thence N. 80 ½ W. 105 feet to a stake 3x on East side of said 40 foot street; thence along said street S. 9 ½ W. 210 feet to the beginning corner. These are the same lots of land conveyed to me by Joseph H. Earle and others by deed dated April 4, 1799 and recorded in R. M. C. Office for Greenville County in Volume 54, page 6.
