Township, on the Augusta Road and having the following  
metes and bounds according to a plat made by W. J. Riddle  
Surveyor Nov. 26th 1919, to wit:

running thence S. 26° 45' E. 1.27 chs. to iron-pie 37; thence N.

a road leading to Piedmont to a stone 37 near Spring; thence
