Traugham, all that certain piece, parcel or tract of land situate lying and being in the Counties of Greenville and Laurens, in the State of South Carolina, on the North east side of Horse Creek, waters of Needy Run, Beginning at a new corner in said creek under the bridge, thence along the road S 66 1/2 E 2.00 angle in road, thence S 75 E 1.28 angle N 79 E 2.72 angle S 89 2 E 3.00 N 67 E 2.30 S 75 E 4.50 angle N 84 E 1.50 angle N 50 E 2.25 angle N 20 E 1.00 corner in road thence S 11 1/4 E 25.55 Stake 37 is in the field, thence S 5 N 24.34 Stake 37 is on bank of creek, Thence up the meanderings of the creek, to the beginning said tract of land being bounded on the north by Public road and lands of W.
