of Greenville County, in consideration of the sum of Twenty one hundred forty two & 00/100 DOLLARS,  
to us in hand paid at and before the sealing of these presents by Ira Davis

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said  
Ira Davis, his heirs and assigns forever; All that certain piece, parcel  
and tract of land, lying and being situated in the County and State aforesaid,  
and being a portion of the lands this day conveyed to us by J. H. Bothram,  
and known upon a subdivision of the Bothram lands as Tract No. 2,  
and containing 12.92 acres, more or less, and being more particularly  
by described as follows:

Beginning on old road at corner of Tract No. 1, and running thence  
N. 73-30 E. 16.50 to a stake; thence N. 47 W. 12.37 to a stake on old road  
near the Newton Sulliman lands; thence along said old road S. 57  
W. 11.00 to stake on another road; thence along this other road S. 19-30  
E. 7.72 to the beginning corner;

also all that other parcel of land adjoining the aforesaid and con-  
taining acres, more or less, and being a portion of tract No. 3. Be-  
ginning at corner of tract No. 2 and running thence S. 72 W. 12.37 to  
stake; thence S. 16-50 E. 7.90 to stake on creek; thence down said  
creek or branch to corner at iron pin; thence leaving branch and  
running thence N. 32-20 W. 20.50 to pin; thence S. 57 W. 5.15 to  
beginning corner.

every person whomsoever lawfully claiming or to claim the same, or any part thereof.
