T. L. McCall, his heirs and assigns, forever, all that certain parcels of land situated lying and being in Blue and Oak Townships, State aforesaid County aforesaid, bounded by lands of P. S. Owens, Mills of Woods, A. M. McMurphy and land formerly owned by J. F.
