All that lot of land in Greenville Township, Greenville County, South Carolina in the City of Greenville on the West side of Augusta Street, known as lot no. 2 on plat of estate of Mrs. H. C. Harris made by Will D. News Oct 22nd 1913 and recorded in Plat Book No page 261. Beginning at a stake on the east side of Augusta Street sixty-five feet south of the southeast corner of Augusta and Harris Streets and running thence with Augusta Street in a southerly direction sixty feet to stake, corner of an eleven foot alley, thence with said alley in an easterly direction one hundred thirty-seven feet to stake corner of lot no. 24, thence with line of lot no. 24 in a northerly direction fifty-seven and six-tenths feet to stake, corner of lot no. 1, thence with line of lot no. 1 in a westerly direction one hundred sixteen feet to the beginning, being one of the lots conveyed to me by W. H. Harris and others by deed dated 28th January 1916 and recorded in Book 37 page 462
