Hunter, her heirs and assigns, the lot of land situate just beyond the corporate limits of the City of Greenville, County and state aforesaid on the corner of Poowee Street, extending and Mountain View Avenue, in what is known as Oakland Heights of the East Side. Beginning at the south west corner of said street and avenue and runs thence in a westerly direction along said avenue 75 feet to a stake; thence in a southerly direction 170 feet and 6 inches to a stake on 19 foot alley; thence in an easterly direction along said alley 80 feet to a stake at corner of said alley and Poowee Street; thence in a northerly direction along Poowee Street 170 feet and 6 inches to the beginning corner, being known as lot no. 13 on plat of W. D. News June 1, 1911 and being the same land conveyed to me by Thomas W. Butler, by deed dated the 10th day of March 1919 and recorded in Vol. 50 page 248.
