in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Florence E. Charles, her heirs and assigns

all that piece, parcel or lot of land in Gantts Township, Greenville County, State of South Carolina. Having the following lines, metes and bounds to wit:

(1) All that piece, parcel and tract of land situate, lying and being in the County of Greenville and State aforesaid in Gantts Township containing Sixty Six (66) acres more or less, being about five and one-half miles from the City of Greenville, S.C. on the Augusta Road now or formerly bounded by lands of J. H. Morgan, Reid Ward, H. W. Vaughan and others; (2) all that certain other tract of land in said County and State containing five (5) acres more or less adjoining the above described tract, and known as the Rebecca Lowell Tract, and lying on both sides of the Augusta Road also (3) all that certain other tract of land in said County and State containing five and one-half (5 1/2) acres more or less adjoining the tract last above described, lying on both sides of the Augusta Road, (4) all that certain other tract of land in said County and State containing five and one-half (5 1/2) acres more or less, adjoining the tract off land last above described, lying on both sides of the Augusta Road, and being the same tract of land which was conveyed to Sallie Lowell by Mrs. Fannie P. Beattie.

Thirty-three and one-third (33 1/3) acres of the above was conveyed to the said Mrs. Rosa K. Achimore by deed bearing date 19th April 1905, recorded in R.M.C. office for said County and State in Vol. or Book O.O.O. page 240 and the remainder by deed dated Oct. 1st. 1908, less the following lands, which have been conveyed very dear and thirteen one-hundredth (10 1/3%) acres by deed bearing date Nov. 19th, 1909, to J. R. Henderson, recorded and Vol. 694, R.M.C. O. Greenville Co. S.C.

One +  $\frac{1}{4}$  (1/4) acre to J. H. Morgan Jr. by deed of July 24th, 1918, recorded in Book 51 at page 160.

Half rights of way, as recorded in Books of Records, Meeme Conveyance Office, Greenville County, S.C. are also reserved from the operation of this conveyance, and reference to them is hereby craved, for date and area, as given by same to the grantee herein named.
