About sixteen miles from Greenville County Court House, and having the following metes and bounds, to wit: Beginning at the forks of Tugalo Road and a settlement road leading from the Tugalo Road to a public road leading from Isaac Tally to Mayetta, thence N. 50° 12' W. 3.50 chains to a stake in road; thence N. 36° 26' 20.835 chains to a stake in road; thence N. 38 26.13.35 chains to a post oak corner of A. M. Taylor's; thence S. 39 1/2° W. 3.50 chains to a willow bat head of branch; thence S. 72° 7.00 chains to a stone; thence S. 31 1/2° W. 9.00 chains to small ash (down), corner of J. C. Garmany's; thence S. 8 1/2° E. 18.35 chains to a post oak, corner of S. B. Tally, thence N. 63 E. 12.50 chains to a stone (formerly a Spanish Oak) corner of S. B.
