Master in and for the County of Greenville, aforesaid, in consideration of the sum of *Fifty one Hundred*  
*(\$5100.00)* Dollars,  
to me paid by the said *J. Hudson Williams*

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release  
unto the said.

*J. Hudson Williams*, the following described real estate: All that  
piece, parcel or lot of land situate, lying and being in the State and  
County aforesaid and in the City of Greenville; Beginning at a corner on  
South Main Street ten feet west of the western corner of the Building  
of Beer Drug Co.; thence with South Main Street S. 75 1/2 ft. forty feet  
to the corner of the lot of Mrs. Willie C. Williams; thence South-  
easterly with Williams line and parallel with line of Beer  
Drug Co. one hundred and fifty feet to a stake; thence N. 75 1/2 E.  
forty feet to a stake on ten foot alley; thence parallel with  
lot of Beer Drug Company and ten feet distant therefrom one  
hundred and fifty feet to the beginning corner, together with  
the right to use the right of way extending across the prop-  
erty formerly owned by J. D. Bridges and W. S. Sassaway as
