Memorandum of agreement made and entered into this the 15th, day of August A.D. 1919 by and between S.B. Huff, party of the first part and MaMie E. Loftis, party of the second part,

W-I-T-N-E-S-S-E-T-H:

That the said party of the first part does hereby agree and contract to sell and convey unto the party of the second part, or her order, by good fee simple warranty deed, free of all encumbrances and with dower renounced, a part of the J.L. Rhodes tract of land situated in the County and State aforesaid and having the following metes and bounds, to-wit: Beginning at an iron pin in the Georgia Road, J.D. Clark's corner and running thence with said road S. 86-3/4 E. 5.77 to pin at bend of road; thence with old road 8. 87.50 E. 9.55 to pin at Andrews' corner; thence with Andrews' line N. 13 E. 25.30 to large poplar at spring; thence N. 84-33 W. 15.84 to stone, Clarks Comer thence with Clarke line S. 12-4 W. 25.47 to the beginning, containing thirty-nine and one-one hundredths (39.01) acres, more or less.

And as consideration for the said tract of land the party of the second part does hereby agree and contract to pay to the party of the first part the sum of \$4876.25 of which sum the amount of \$400.00 is to be paid upon the signing of this contract, and the balence of \$4476.25 is to be paid on or by Jan. 1st, 1920, at which time deed to the said property is to be made and possession

That the said party of the second part does hereby agree and contract to accept the deed to the land as aforesaid, and to pay to the party of the first part the sum of \$4876.25 as consideration for the said tract of lend, said payments to be made as above specified. That the party of the first part is to have the use, occupancy and possession of the lands for the belence of the year 1919 and is to have the rents and profits from said lands for the whole of the year 1919, and the party of the first part is to pay the taxes for the year 1919. And the conveyance as aforesaid shall be made by the party of the first part in as good general condition as they now arr. The party of the second part agrees to take the risk of the houses burning. That the party of the first part agrees to insure the building or buildings on the said property for the amount of # - - - for the remainder of the year 1919 against loss by fire, shall pay the premium on said policy for the balance of the year 1919 and make the policy payable to the party of the second part. And this amount is to settle any loss that may be had by fire until insurance after the first of Jan. 1920 until the expiration of said policy.
