It is further agreed that if the above stipulated option is exercised, then, the said Stacy and Dunigan, their heirs and assigns, shall purchase from the undersigned such material and stock in process as undersigned may have on hand for the manufacture of pumps at the market value thereof and in the event of inability to agree as to the market value, then by an appraisal to be made by three disinterested persons, one of them to be chosen by the undersigned, one of them by the purchasers, and these two to select the third.
