This agreement made this the 14th, day of April 1921, between Mrs. A.C. Ferguson, of the first part, and R.L. Cruikshank Trustee of the Second Part, both of the City and County of Greenville, State of South Carolina, Witnesseth:

That whereas the two parties own each a lot in the City of Greenville adjacent to each other, and fronting on Pendleton St. The lot of Mrs. Ferguson's being described in a deed from Joseph B.-Scruggs to L.B. Cline, made in 1850, and registered in book K.K., page 415, of the Record of Deeds for Greenville County and the said Mrs. Ferguson, desires now to improve her lot by placing thereon a two story and basement brick store building. Now therefor it is agreed that she will set the partition wall between them one half on her, ground and one half on the ground of the second party, according to the provisions of the statute law of South Carolina, in regard to such party walls. And that when hereafter the second party or any person for whom he holds the title in trust there heirs or assigns shall use said wall, he or they shall pay to the first party or her. legal represent for one half of said partition wall, so far as he or they make use of the same, as is also provided by existing statute in said State.

The second party grants to the first party, the right to remove the present wall of a small wooden building now on his lot, next to the division line, by taking off a sufficient distance, say nine or ten inches, on that side of the small building, as will give room for her to bring up this party wall - provided that the first party shall set in a temporary board wall on that side at her own expence, and as soon as the brick wall is up, take out this temporary partition so that the new brick wall, will serve for the wall of his small wooden building on that side.

To have and to hold all and singular the said one-half of said brick wall unto the said S.H.Kress and Co., its successors and assigns forever.

And I do hereby bind myself, as general guardian of the said minors, and my successors, and said minors, to warrant and forever defemd the same unto the said S.H. Kress and Co., its successors and assigns, against me as general guardian aforesaid, and my successors, the said minors and all other persons lawfully claiming said well, or any part thereof.
