5th. In trust further to reconvey to me or my assigns any of said property not theretofore sold and conveyed at any time upon the written request of myself and two-thirds of my said creditors in amount as of date of this agreement.

And I do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said G. Allen Banks, his heirs and assigns, against me and my heirs and all other persons lawfully claiming, or to claim the same or any part thereof.
