(The receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Mrs. Florence McElroy Wade, her heirs and assigns forever, All that certain piece, parcel and lot of land, lying and being situated in said County and State, on the Augusta Road, about three miles from Greenville Court House and being known and designated as Lot #1 upon a plat of the W. B. Daniel Property, said plat being recorded in the Office of the P. M. C. of Greenville County, and containing 2.62 acres, more or less, beginning at a certain iron pin on the Augusta Road at corner of property formerly of W. P.
