(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Fred H. Plexico,

All that said lot of land in State of South Carolina, County of Greenville in the City of Greenville, on Arlington Avenue (formerly Darlington Street) described as follows: Beginning on an Iron pin on Arlington Avenue, County of Greenville W. Ellison lot and beginning thence with line of that lot N. 27 E. 114 feet, 5 inches to an iron pin; thence S. 71 3/4 E. 33 feet 7 1/2 inches to a stake; thence S. 8 3/4 E. 116 feet to a stake on Arlington Avenue; thence with said Avenue N. 69 W. 30 feet to the beginning corner. Being the same land to me J. C. Turner by Fred H. Plexico by deed dated July 14th 1920 and recorded in R. M. C. Office for Greenville County in Vol. 70, at Page 67. As a part of the consideration for this deed the grantee herein do hereby assume and agree to pay a certain note and mortgage given on the land herein above described, by Fred H. Plexico to J. B. Mallock in the sum of \$3750.00. Said mortgage being dated June 16, 1920, and recorded in Vol. 94 Page 67, said mortgage bearing interest at eight per cent, payable annually.

Also as a part of the consideration, the grantee herein assumes and agrees to pay the unpaid portion of a five hundred Dollar mortgage given on the premises above described, by J. C. Turner to Fred H. Plexico, and recorded in Vol. 96, Page 68. Said unpaid portion being \$400.00, payable in four (4) equal installments of \$100.00 each on the 15th day of each of the following months, September, October, November, and December, 1920. Interest account of this mortgage is at the rate of eight percent per annum. Dated July 14, 1920.

The grantee herein agrees and assumes to pay the interest account of the above described mortgage from the date of the said mortgage. Rents, taxes, and insurance premiums are to be pro-rated as of the date of this conveyance.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Fred H. Plexico, his
