Steele, their heirs and assigns forever. All those two certain lots of land situate in the City of Greenville, County and State aforesaid, known and designated as Lots 11 and 29 on plat of Thos. M. Walker Company's sub-division made August 1919 and having the following metes and bounds, to-wit: Beginning at a stake on South Main Street, corner of lot No. 12 and running thence with line of lots 12 and 28, N. 10-14 W. 140.2 feet to Chicora Street thence with Chicora Street N. 80-15 E. 25 feet to corner of lot No. 30; thence with line of lots 30 and 10, S. 10-13 E. 141.8 feet to South Main Street; thence with South Main Street in a westerly direction 25 feet to the beginning corner. (2) A mortgage given by Thomas M. Walker to the Board of Trustees of Chevere College, August 26, 1919 to secure the sum of twenty-five hundred (\$2,500.00) Dollars due five years after date with interest from date at six per cent. per annum.

(3) A mortgage given by W.D. Workman to the Thomas M. Walker Company, August 26, 1919 to secure the sum of Two thousand (\$2,000.00) Dollars due two years after date with interest at six per cent. per annum. This mortgage covering Lot No. 11 only.

(4) A mortgage given by W.D. Workman to the Thomas M. Walker Company, August 26, 1919 to secure the sum of twelve hundred and fifty (\$1,250.00) Dollars, due \$416.66 two years after date; \$416.66 four years after date; \$416.66 six years after date, with interest at six per cent. per annum.
