& Investment Company, All that piece, parcel or lot of land either partly or wholly in Paris Mountain Township, Greenville County, State of South Carolina, between Franklin and Buncombe Roads, described as follows:

Beginning at an iron pin near a brick gate post in the Franklin Road, and running thence S. 5-17 E. 645.9 feet to iron pin; thence S. 45-03 W. 822.9 feet to an iron pin at twin oaks; thence N. 60-10 W. 309 feet to an iron pin; thence S. 46-32 W. 27-1/2 feet to an iron pin; thence S. 46-05 W. 232 feet to an iron pin; thence S. 73-19 W. 501.6 feet to an iron pin; thence N. 30-24 W. 194 feet to an iron pin at cherry tree; thence N. 19-56 W. 154 feet to an iron pin at Catalpa; thence N. 15-1/2 E. 120 feet to C.I. Monument; thence N. 11-1/2 W. 502.8 feet to C.I. Monument; thence N. 24-30 E. 1162.9 feet with line of land now or formerly belonging to Lucy B. Perry to an iron pin on the Franklin Road; thence with the Franklin Road S. 64-24 E. 1313.1 feet to the beginning corner.

As shown on a plat made by J.E. Sirrine & Company on February 26, 1921, and revised October 10, 1922. The above tract contains 53.20 acres, more or less and is known as the Sans Souci Country Club and is the same land conveyed to the grantor by Franklin Holding Company on July 1, 1914, deed recorded in R.M.C. office for Greenville County in Volume 25, at page 57, the western boundary of which tract was fixed between the grantor and Lucy B. Perry by agreement dated March 3, 1921, and recorded in R.M.C. office for Greenville County in Book 61, page 139. Excepting, however, two lots conveyed by Sans Souci Country Club - one to Carrie W. Stradley, April 3, 1916, of record in Volume 25, page 135, containing 1.02 acres, and the other by deed of Sans Souci Country Club to Cora T. Tannahill, dated May 3, 1917, and recorded in Volume 25, page 206, containing 44/100 of an acre.

This conveyance is made in accordance with a Resolution passed by the Directors of the Sans Souci Country Club, December 27th, 1922, and confirmed and ratified by the members of said Club at a duly called and held meeting, July 10th, 1923.
