KNOW ALL MEN BY THESE PRESENTS, That Southern Textile Machinery Company a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Ten dollars and other valuable considerations DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto V. W. Carter, and his heirs

and assigns forever: All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Ward 3, of the City of Greenville, having the following metes and bounds, to-wit: Beginning at a point on the East side of Jackson Street 125 feet Southward from the Southeast corner of Court and Jackson Streets, which point is in the center of the right of way of the Southern Railway Company upon which is laid a sidetrack running in the rear of the building of the Carolina Supply Company and running thence along the East side of Jackson Street, in a Southerly direction sixty-three (63) feet seven (7) inches, more or less, to a ten-foot alley separating the property hereby described from the property of The Home Holding Company; thence in an Easterly direction along the Northern line of said alley one hundred and eight feet (108 ft.) three inches (3 ins.), more or less, to an iron pin in line of lot of estate of T. O. Donaldson; thence along last mentioned line in a northerly direction, sixty-three (63) feet and seven inches (7 ins.), more or less, to a point in the center of the railway sidetrack above mentioned; thence in a westerly direction along the center of said sidetrack one hundred and eight feet (108 ft.) and three inches (3 ins.), more or less, to the beginning corner.

It being understood, however, that a strip of said lot 7 1/2 feet wide along the northern line of said lot heretofore described, being one-half (1/2) of the right of way conveyed to Southern Railway is included in the above description and this conveyance is subject to the said right of way of said railway.

This being the same tract of land conveyed to Southern Textile Machinery Company by Riverside Land Company by deed recorded in the R.M.C. office for Greenville County in Vol. 25, at page 489. This conveyance is made subject to mortgage indebtedness of Thirty-six thousand Dollars (\$36,000.00), this being balance now due to Life Insurance Company of Virginia and J. W. Norwood upon mortgages recorded in Vol. 78, page 256, and Vol. 97 at page 109, respectively which is assumed by Grantee.
