in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said W. D. Workman my one-seventh ( $\frac{1}{7}$ ) undivided interest in

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

In City of Greenville, beginning at a stake on the north side of August Street at the corner of lot of J. S. Conrad and running thence with Conrad's line N. 24 W. 50 feet to a stake thence S. 69 W. 83 feet to a stake thence S. 53 E. 87 feet to a stake on Augusta Street thence with Augusta Street N. 39 1/4 E. 48.5 feet to the beginning corner being the corner lot of land conveyed by Jas. E. Payne to H. B. Battle as Trustee for benefit of himself, P. L. Bruckbank, J. M. Richardson, W. A. Wallace, Frank R. Deshay, J. C. Martin and Jno. C. Grantee also agrees to pay all taxes, both State and County, accrued to date on my one-seventh interest in said lot same herein conveyed. The grantee herein is to be entitled to all accrued rents due the grantor.
