unto the said *H. D. Grant his heirs and assigns forever*  
*all that certain piece, parcel, lot or tract of land*  
situated in the Township of Greenville County, State of South Carolina.

*lying, situate and being in near corporate limits  
City of Greenville, Greenville Township, County of  
Greenville and State of South Carolina and in  
sub-division known as Cherokee Park and being  
all of Lot 1041 and one-half of Lot 1040 according  
to plat of said subdivision made by Brodie & Bedell  
Engineers and recorded in the office of the  
Register of Mesne Conveyances for Greenville County  
State of South Carolina, in Plat Book "C" at page  
46 and having the following metes and bounds,*

*Beginning at a point corner or intersection of  
Kramer Avenue and Gateways Road and running  
thence with Kramer Avenue S. 74-30' W. 15 feet  
thence S. 28-09' W. 66 feet and 7 inches to corner of  
lot now or formerly owned by W. A. Jones thence  
along line of said Jones lot S. 62-32' E. 168 feet
