(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Henry P. McGee All that certain piece parcel or tract of land lying land being in the city of Greenville, County of Greenville, state aforesaid situated at southeast corner of Earle and Wilton Sts., having a frontage upon Earle St. of Sixty-five and one-half feet and containing the following metes and bounds: Beginning at a stake on Earle S. E. corner of Earle and Wilton Sts. running with Wilton St. S. 5 $\frac{1}{2}$ W. one hundred and thirty-four and one-half (134 $\frac{1}{2}$) feet to a stake on Wilton St. at corner lot #1, thence with line of such lot S. 84 $\frac{1}{2}$ E. Sixty-five and one-half feet to a stake at corner lot #1, thence with line of such lot S. N. 5 $\frac{1}{2}$ E. One hundred and thirty-four and one-half (134 $\frac{1}{2}$) feet to stake on Earle St. at corner of lot #1, thence with Earle St. N. 84 $\frac{1}{2}$ W.
