(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said M. A. Smith, All that certain tract of land situated in the County and State aforesaid, near Paris Mountain, containing fifty acres more or less, and described as follows: Beginning at a stone just west of the road running out to the C. O. Allen place, and running thence N. 68° 2' E. four hundred ninety-five (495) feet to R. O. Stump, thence N. 40° 1/2 E. six hundred seven (607) feet to a stone; thence S. 51° 3' E. (584) five hundred eighty-four feet to a stone; thence S. 79° W. six hundred seventy-five (675) feet to a stone; thence S. 82° 44' W. two hundred sixty-four (264) feet to a stone; thence S. 1° 3' E. five hundred fifteen (515) feet crossing the road to a stone; thence S. 67° W. less than one hundred feet to corner of said tract; thence S. 79° W. three hundred forty-nine (349) feet to a stone; thence in a straight line, crossing the last mentioned road and the C.
