and other considerations

at and before the sealing of these presents by Hassie K. Smith

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Hassie K. Smith all our interest, right, claim, title or inheritance in all that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, containing eighty-three and 23/100 (83.25) acres, more or less, and bounded by the lands of Mrs. M. Gaines, D.T. Coker, Frank A. Kilgore, Joe H. Kilgore, Earle Hughes and others. Beginning at a stone 3x on Greenville road and running thence N. 16° 10' W. 16.04 to a stake 3x; thence S. 45° 45' W. 2.42 to a post oak 3x; thence S. 89° 30' W. 4.66 to a stone; thence N. 3° 30' W. 5.50 to a stake for gum on Peters Creek; thence down the meanderings of the old creek run 3x to a stake; thence N. 16° 10' W. 32.40 to an iron pin in public road; thence N. 21° 15' E. 16.80 to a stone on branch; thence down the branch 4.70 to a stone thence S. 21° 15' E. 16.80 to a stake in road; thence with the road 6.12 to a stake; thence S. 11° E. 7.90 to a stake; N. 81° 30' E. 3.92 to a wild cherry 3x; thence N. 80° 30' E. 7.24 to a stake in private road; thence S. 25° E. 7.57 to a stake; thence S. 15° 45' W. 5.50 to a stake; thence S. 3° E. 27.70 to a stake; thence S. 63° W. 10.80 to the beginning.
