at and before the sealing of these presents by J. Walter Gray

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said All that tract of land situate in the State and County aforesaid in Cleveland Township, bounded by lands of New, Robinson and Mrs. Beattie, having the following metes and bounds, to-wit: Beginning at a stake on the Jones Gap Road and running thence S 41° 5' E. 18.10 to a pine X3om; thence S. 54 E. 17.15 to a stone by pine; thence N. 51° E. 4.15 to an iron pin; thence N. 17.5 E. 20.60 to persimmon X3om; thence N. 67° 3/4 W. 16.75 to a stake on Jones Gap Road; thence with said Road in a southerly direction to the beginning, containing 50 acres, more or less; this being part of a tract of 150 acres as shown in plat made by W.A. Hester, May 10, 1921, and is a part of the tract of 359 1/4 acres, conveyed to me by F.F. Beattie and N.C. Poe, Jr by deed dated April 1, 1920, recorded in Vol. 68, page 174. And the grantor herein does hereby also grant, bargain, sell and release unto said Grantee all water power rights and reservations of water power, heretofore made and reserved in a deed conveying a tract of 85 acres adjoining the above described tract, dated May 28, 1921, recorded in Vol. 55, page 176.

It is agreed that A.G. New reserves ~~the right~~ to himself, his heirs and assigns, the right to establish a good wagon road through the above described property with right of egress and ingress through said property to the railroad siding and the public roads. It is further agreed, that should said Jones Gap Road be moved or changed so that part of the above described 50 acre tract shall lie between said road and the land owned by A.G. New, then the said A.G. New, his heirs and assigns shall have the option and privilege of purchasing so much of said land as shall lie between the land now owned by the said A.G. New, and said road as changed at the price of thirty (\$30.00) per acre; said option to run for 90 days only, after such change in said road.
