KNOW ALL MEN BY THESE PRESENTS, That, The Realty Trust Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of One and no 100 (#100) DOLLARS, and other valuable considerations and the foregoing recitals to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinabove named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto W.W. Dodson

All those certain twenty five (25) lots of land situate lying and being in the County and state aforesaid in Greenville Township about one and one-half miles northwest of Greenville Court House, in a section known as City View being Lots nos 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24 and 25 as shown by a plat made for Thos. P. Earle dated November 21, 1912. The land herein conveyed is described by metes and bounds as follows:

Lots 1-17 inclusive in Block "P" beginning at northeast corner of 1st St. and O'Neal Avenue, and running thence with O'Neal Avenue N 80 E. 467 feet to a pine on O'Neal Avenue, corner of Lot no 9; thence N 11-50 W. 288 feet to a pine on Center Street, corner of Lot no 10; thence S 18-2 W. with Center Street 408 feet to a pine on 1/2 M.C.A. Street, corner of Lot no 17; thence S. 0-30 W. with 1/2 M.C.A. Street 306 feet to the beginning corner.

Also Lots 180 to 250 inclusive in Block "E" beginning on the northeast corner of 1/2 M.C.A. Street and South Street and running thence with Center Street N 82 E. 400 feet to a pine on Center Street, corner of lot no 25; thence N 11-50 W. 156 feet to a pine at corner of lot no 25; thence S. 85 W. 361 feet to a pine on 1/2 M.C.A. Street, thence S. 0-30 W. with 1/2 M.C.A. Street 179 feet to the beginning corner, being part of land conveyed to Thos. P. Earle by J. H. O'Neal by deed dated October 16, 1909 and recorded in Volume 4, page 764 and by said Thos. P. Earle conveyed to W.W. Dodson by deed recorded in Vol. 39, page 154.

Now, therefore, for the purpose of removing any cloud upon title to said lot and to vest title in W.W. Dodson and his grantees

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and

heirs and assigns, against itself and its successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers

on this the 7th day of April in the year of our Lord one thousand nine hundred and twenty two and in the one hundred and forty sixth year of the Sovereignty and Independence of the United States of America.
