- (3) The property shall be used only for residential purposes and no use shall be made thereof which would constitute a nuisance or injure the value of neighboring lots.
- (4) No dwelling house costing less than Seventy-five hundred (\$7500.00) Dollars shall be erected on said property nearer to Byrd Boulevard than 60 feet.
- (5) The grantor reserves the right to lay and place or to authorize the laying and placing of street car tracks, sewers, gutters, paving and pipes, the erection of telephone, telegraph and electric light poles or the placing of any other public utility in or along any of the roadways without liability to compensate any lot owner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and heirs and assigns forever

Nevertheless upon the following restrictions, conditions, which are expressly for the benefit of all persons owning lots in said subdivision, to-wit: (1) This property nor any part thereof
