to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (the receipt whereof is hereby acknowledged),

has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto B. E. Lee his heirs and

assigns, All that two certain pieces, parcels or lots of land in Gandy Township, County and state aforesaid, at Gandy Station, known as lots No. 1 and 5, on plan of property of Greenville Realty & Investment Company made by R. E. Dalton Esq., December 1923 and being described separately according to said plan as follows:

Lot No. 1: Beginning at a stake on the National Highway joints corners of lots Nos. 1 and 2, said highway thence along line of lot No. 2, N. 70-10 E. 570.8 feet to stake on line of lot No. 6; thence along line of lot No. 6, N. 21-15 E. 220.5 feet to stake joint corner of lots Nos. 1 and 6; thence N. 66-30 W. 659.8 feet to iron pine on the National Highway, thence along said National Highway S. 20-45 E. 159.8 feet to the beginning corner.

Lot No. 5: Beginning at a stake corner of lot No. 4 and said lots and running thence with line of said lots N. 83-41 E. 349 feet to stake corner of lot No. 6; thence with line of said lots N. 21-15 W. 135 feet to center of 16-foot road; thence with center of said road S. 20-45 W. 340 feet to stake, thence N. 13-35 W. crossing the White Horse Road 152.3 feet to the beginning corner.
