And Whereas, on the 21st, of August 1920 Greer Cotton Seed Oil & Fertilizer Company did execute and deliver to Greer Fertilizer Company a lease of the property hereinafter described upon the terms therein stated and it is desired to renew said lease and add thereto certain new and additional terms;

Now, Therefore, This Agreement entered into between Greer Cotton Seed Oil & Fortilizer Company, hereinafter called Lessee, Witnesseth: hereinafter called Lesser, and Greer Fertilizer Company, hereinafter called Lessee, Witnesseth: That the Lessor in consideration of the sum of One Dollar paid to it and the further consideration that the improvements and additions to the plant herein leased made by the lessee herein under a former lease, said improvements being shown by itemized list hereto attached and marked Exhibit "A", shall from the termination of this lease become the absolute property of the lessor, one Dollar paid by the lessee (receipt whereof is hereby acknowledged), hereby lease to the lessee from the term beginning September 1st, 1922, and ending August 1st, 1923, the entire plant and Equipment of the lessor situate in the Town of Greer.

It is mutually agreed that the lessee shall have the right to make such improvements in and additions to said plant as may be agreed to by the President end Treasurer of the Lessor, and that upon the termination of this lease, that all such improvements and additions and also the improvements and additions as shown in Exhibot "A" attached to this lease shall become the absolute property of the Lessor.

It is mutually agreed that upon the failure of the lessee to insure the whole or any part of the plant herein leased, that the lessor shall have the right to take out such insurance and charge the expense of same to the lessee.

This agreement and lease is supplemental to the agreement entered into February 25th, 1920 between W.C. Beacham, Trustee and the lessee herein.

It is further mutually egreed that this lesse shall not be assigned to any one without the written consent of the lessor indorsed hereon.
