That certain piece, parcel or tract of land situate, lying and being in Cleveland Township,
County of Greenville, State of South Carolina, on both sides of Little Fall Creek, containing 800 acres, more or less, and being the same tract of land conveyed by W.M. Thomas unto Charles Gosnell, under deed dated March 2, 1869, recorded in the Office of the Registrar of Mesne Conveyance, in and for Greenville County,, State of South Carolina, in Deed Book "Y", at page 806.

Together with all and singular, the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To have and to hold, all and singular the premises before mentioned unto the said Saluda Land and Lumber Company, its successors and assigns forever.
