- (3) That the party of the second part shall not have the right to allow any person or persons to tap on or connect with his water pipe, but said tap or connection herein granted is sold for the exclusive use of furnishing water to said lot now owned by the party of the second part, and in the event the party of the second part or his assigns, should attempt to violate this condition the party of the first part shall have the right to disconnect party of the second part from the said water main of the party of the first part and retain money already paid as liquidated damages. W.E. Howard, Lessor, in consideration of the rental hereinafter mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto W.H. Cassell, Lessee, for the following use, viz: General store and Warehouse the one story store-room and metal feed house located on property of Southern Railway Co. in town of West Greenville, S.C. for the term of one year from Jan. 1st, 1923 and the said lessee in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of Three hundred sixty and no/100 Dollars per year payable monthly.

The lessee hereby agree to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only require of the lessor, the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from leaks should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time become immediately due and payable.

Outside signs to be erected that may connect with the parapet or any other outside part of the building must be consented to by the lessor before being erected.

The above consideration evidenced by twelve notes for \$30.00 each, payable monthly, beginning Feb. 1st, 1923. In case of destruction of building by fire or otherwise making it unfit for the purpose leased all unpaid notes shall become null and void, or in case Southern Railway Co. cancels lease to the said W.E. Howard and demand possession of land and lessee W.H. Cassell is forced to move this lease shall terminate and no rents shall be due after date of removal, but under other circumstances this lease shall be in full force.

To have and to hold the said premises unto the said lessee W.H. Cassell, executors or administrators for the said term.
