Beginning at an iron pin on the southwest side of Augusta Court, joint corner of lots Nos. 36 and 37, and running thence with the joint line of said lots S. 50-57 W. 174.5 feet to an iron pin, thence N. 41-30 W. 85 feet to an iron pin in line of lots Nos. 35 and 36, thence with the joint line of said lots N. 58-49 E. 189.4 feet to an iron pin on Augusta Court, thence with Augusta Court S. 29-33 E. 60 feet to the point of beginning.
