(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the

Kate B. Henderson. All that certain lot of land situate on the east side of North Main Street in the City of Greenville, in the County and State aforesaid and having the following meters and bounds to wit: Beginning at an iron pin on the said east side of North Main Street, N. E. Willis' corner and running thence with said North Main Street N. 19-39 E. 106 feet 5 inches to an iron pin, S. P. Haynesworth's corner; thence with said Haynesworth's line S. 70-30 E. 208 feet 4 inches to an iron pin; thence S. 18 W. 102 feet 5 inches to an iron pin, thence N. 69-15 W. 211 feet 3 inches to the beginning corner; Being the same lot conveyed to me by D. S. Johnston by deed dated December 31, 1912 and recorded in D. M. C. office for Greenville County in vol. 18, page 8.

Also all that certain strip of land fronting on the east side of North Main Street in the City of Greenville, County and State aforesaid, being 18 inches in width and having the following meters and bounds, to wit: Beginning on Main Street at corner common to lot of W. P. Henderson and lot conveyed to J. D. Bridges by C. E. Haynesworth and running thence with line of Henderson's lot S. 70-30 E. 208 feet, thence N. 18-54 E. 18 inches, thence parallel with line of Henderson's lot N. 70-30 W. approximately 208 feet to Main Street thence with Main Street S. 19-39 W. 18 inches to the beginning corner. Being the same strip of land conveyed to me by J. D. Bridges by deed dated March 11, 1921. Deed not yet recorded.

Also all my right title and interest in and to a certain strip of land 10 feet in width extending from Earle Street in a southerly direction along the rear line of the J. D. Bridges lot to my line, said strip of land being approximately 102 feet in length and being the same conveyed to me by J. D. Bridges by deed dated March 11, 1921.

As a part of the consideration hereinabove expressed, the Grantor hereby agrees to assume and pay the balance due on mortgage of \$7,000.00 given by me to the Equitable Life Assurance Society in December, 1920.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Kate B. Henderson, her
