(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the

Rudolf Anderson & Kenneth M. Bass
All those pieces, parcels or certain lots of land in Greenville Township, Greenville County State of South Carolina, being lots numbered fifty four, fifty five, fifty seven, fifty eight, fifty nine, sixty, sixty one, sixty two, sixty three and sixty four as the said division of the Chiles and Bacon property take per plat of Sitzpatrick Perry company of date September 1919, recorded in Plat Book "B" at page 153 to which reference is hereby made as a part of this description these being the same lots conveyed to me by Rudolf Anderson by deed dated May 11th 1922 and recorded in R. M. C. Office of Greenville County in vol 78 page 156.

The Grantor herein assumes and agrees to pay a certain mortgage of \$5,332.33 which is payable in three equal annual installments, one, two and three years from March 15, 1922 with interest at seven per cent, also a junior mortgage of \$1,666.67, which is payable in three equal annual installments, one, two and three years from March 15th 1922 with interest at seven per cent.

It is understood that the state and county taxes for 1922 are to be pro-rated.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Rudolf Anderson and Kenneth M. Bass their

heirs and assigns, forever.
Provided, that a building line of forty feet be maintained, and that houses of a cost of not less than forty-five hundred dollars be erected on said lots.
