All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, just outside of the corporate limits in the City of Greenville, on the south side of Prentiss Avenue, between lot no. 8 Block "L" on a plat of three parcels, recorded in R. M. C. Office for Greenville County in Plat Book "C" page 176 reference to said plat being drawn for a more complete description. This being the same property conveyed to me by Walter W.
