(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the
said A. B. Gransell and his heirs and assigns: All those
two certain pieces, parcels or lots of land, situate, lying and
being in the State and County aforesaid, in Greenville Township,
on the east side of the Augusta Road, and being known
and designated as Lots Nos. 104 and 105 of the Shaver
Park Subdivision, as shown on a plat made by R. E.
Baird, Long v. March 1923 and having according to said
plat the following lines and bounds to-wit:

Lot Number 104: Beginning at an iron pin on the
Eastern side of the Augusta Road, joint corner of lots
Nos. 104 and 105, and running thence with the joint
line of said lots N. 36-08 E. 259.7 feet to an iron pin, thence
N. 54-02 W. 70.5 feet to an iron pin, joint corner of lots
Nos. 103 and 104, thence with the joint line of said
lots S. 58-24 W. 234 feet to an iron pin on the Eastern
side of the Augusta Road, thence with said Augusta
Road S. 33-19 E. 45 feet to the beginning corner.

Lot Number 105: Beginning at an iron pin on the
East side of the Augusta Road, joint corner of lots Nos.
105 and 106, and running thence with the Eastern side
of Augusta Road N. 33-019 W. 70 feet to an iron pin, joint
corner of lots Nos. 104 and 105, thence with the joint
line of said lots N. 56-08 E. 259.7 feet to an iron pin,
thence S. 54-08 E. 72.4 feet to an iron pin, thence with
the joint line of lots Nos. 105 and 106, S. 55-47 W. 284.5
feet to the beginning corner.
