(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Greenville Realty & Investment Company, its successors and assigns: All those certain two lots of land in the City of Greenville, County and State aforesaid, on the South side of West Washington Street, and being described as follows: as Lots Nos. 2 and 8, of subdivision known as W.D. Workman property, as shown on Plat recorded in Plat Book E., page 293, and being more fully and separately described as follows:

Lot No. 2: Beginning at a point on 15 foot alley at joint corners of Lot Nos. 2 and 3 and running thence N. 42° 30' E. 161.7 feet to pin on S. side of W. Washington Street; thence along said Street S. 47° 44' E. 21 feet to pin; thence S. 42° 30' W. 162.1 feet to pin on 15 foot alley, at corner of lots Nos. 2 and 1; thence N. 46° 36' W. 21 feet to point of beginning.

Lot No. 8: Beginning at a point at Southern joint corners of Lots No. 8 and 9 and running thence N. 43° 21' E. 75.3 feet to pin on S. side of W. Washington Street; thence S. 47° 44' E. 20 feet to pin; thence S. 43° 21' W. 75.6 feet to pin at joint corner of lots Nos. 7 and 8; thence N. 46° 36' W. 20 feet to point of beginning.

These being the same two lots conveyed to the grantor by F.G. Mauldin by deed dated August 14, 1923, and recorded in Vol. 90, page 158.

As a part of the consideration for this conveyance the Grantee herein assumes and agrees to pay two mortgages covering Lot No. 2 as follows: \$1200.00, dated August 17th, 1922, payable 1/3 Jan. 1, 1924; 1/3 August 17, 1924; and 1/3 August 17th, 1925. And second mortgage, \$1200.00, payable 1/3 August 17, 1926; 1/3 August 17, 1927 and 1/3 August 17, 1928, said mortgages being of record in the R.M.C. Office for Greenville County. And, mortgage indebtedness on Lot No. 8, as follows: First mortgage, \$1200.00 payable 1/3 Jan. 1, 1924; 1/3 August 17, 1924; and 1/3 August 17th, 1925, and second mortgage, \$1200.00 payable in three equal annual instalments on the 17th day of August, 1926, 1927 and 1928.
