 as lot no. 43 Block "B" of Eagle Park as shown on  
 plat recorded in R. M. C. Office for Greenville County  
 in plat Book C page 538 and having the following  
 lines and corners: Beginning at an iron pipe on  
 Tindal Avenue, corner of lot 2, being 185.1 feet from  
 Republic Street and running thence west line of lots  
 2 and 3 S 28-42 E. 156.8 feet to an iron pipe corner of  
 lot 6; thence with line of lot 6 N 75-01 E. 50 feet to
