Leonard, deceased, and Thomas Keating, individually, of the County and State eforesaid, parties of the first part, hereinafter designated as and called the "Lessors", and Southern Public Utilities Company, a corporation duly organized and existing under and by virtue of the laws of the State of deine, party of the second part, hereinafter designated as and called the "Lessee", Witnesseth:
