KNOW ALL MEN BY THESE PRESENTS, That The American Bank and Trust Company, a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina, pursuant to the authority contained in said deed and for, and in consideration of the sum of ten and other valuable considerations to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Mary Busch Smith

All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, South Carolina, near the Augusta Road School site, on Waccamaw Avenue (line run)

and being known and designated as lot No. 51 of the C. B. MARTIN sub-division, as shown on a plat of record in Plat Book "F," page 102, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Waccamaw Avenue, joint corner of lots 4 and 6 and running thence N. 71-36 W. 174.6 feet to an iron pin, joint corner of lots 4, 6, 12 and 5; thence S. 116-51 W. 69.9 feet to an iron pin on line of lot 7, thence S. 71-35 E. 183.4 feet to an iron pin on Waccamaw Avenue; thence along west side of Waccamaw Avenue N. 12-10 E. 70.3 feet to the point of beginning.

Nevertheless, upon the following conditions, which conditions are part of the consideration for this deed and are expressly for the benefit of all owners of lots as shown on plat above referred to, to-wit:

- (1) No building shall be erected nearer to the abutting sidewalk than thirty feet.
- (2) The property herein conveyed shall never be sold, rented, or otherwise disposed of to a person, or persons, having any percentage of Negro blood.
- (3) The property herein conveyed shall never be used for other than residential purposes, and no residence costing less than four thousand dollars shall ever be erected thereon.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and her

heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

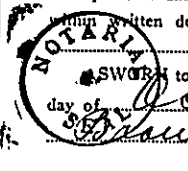
